## **100 Point Identification AML/CTF Check List**

- All applicants/directors, beneficiaries and authorised agents on the account must complete a 100-point identification and AML/CTF check.
- Photocopies of identification documents must contain the person's full name and be certified by an Authorised Person (see below).
- One form of identification must show your current residential address.
- **Do not** send us originals of your identification documents.

<ul> <li>Bank Statement stating name and address (from last 3 months)</li> </ul>	25 Points
<ul> <li>Rental Agreement/Letter from Real Estate Agent</li> </ul>	25 Points

#### AML/CTF check

Must include for Australian Residents;

- Drivers Licence (ACT, VIC or QLD)
- Australian Passport
- Medicare Card

Must include for Foreign Residents

- Employment Visa/Foreign Passport (Non Australian Resident)
- International Drivers Licence
- Utility Bill/Credit Card Statement (including postal address)
- Copy of Credit Card/EFTPOS Card

#### **Certifying Your Documents**
